A one-time, non-refundable **joining fee of \$100.00** is to be submitted along with this completed application. The undersigned hereby makes application for membership and, when approved by the Board of Directors, agrees to abide by all rules and regulations as set forth in the by-laws of Bay Springs Recreation Association, or as may be adopted by the Board of Directors of the Association. It is understood that dues for active membership are \$1,320.00 per year, payable in monthly installments of **110.00 via bank draft**. It is further understood that this membership is for a period of not less than 1 year, and that the applicant will pay legal fees, court costs and any other fees incurred by Bay Springs Rec. Assoc. in an attempt to collect dues or debt owed by the applicant. The only exception to this is if applicant moves outside a 25-mile radius of club property. After 1-year, written notice of membership cancellation is required. It is understood that monthly dues are payable by **BANK DRAFT ONLY** and this draft will occur around the 15th of each month. The attached bank draft authorization form is to be submitted with this application. A late fee of \$5.00 will be charged if your draft is returned for insufficient funds. Use of club facilities will begin upon remittance of this application unless notified otherwise. (Questions-Call or text Susan at 601-764-8444) Monthly dues are subject to change at any time at the discretion of the board. When the number of club members reaches 190, new members will be placed on a waiting list to join. If you cancel and decide to be reinstated, you will be required to pay the joining fee again and if membership is full at 190, you will be placed on a waiting list.
